Thank you for the invitation to submit Community Project Funding requests for the Northern Mariana Islands.

I am requesting funding for Homestead Wastewater and Lift Station Infrastructure in Fiscal Year 2027. The entity to receive funding for this project is the Department of Public Lands, Joeten Dan Dan Bldg, Saipan, MP 96950. Funding would be used to install a sewer system and main lift station in the As Gonno area of Southern Saipan to support the development of approximately 440 homestead lots. The project is an appropriate use of taxpayer funds because it will provide essential infrastructure necessary for safe housing development while supporting long-term public health and environmental protection through proper wastewater management.

The project has a federal nexus because it is for the purposes authorized in Section 306 of the Consolidated Farm and Rural Development Act, 7 U.S. Code section 1926(a)(2).
